

Summary Report on a Toolbox for Measuring the Effectiveness of Programs Working on behavioral change

I. Background

The Belgian Non-Governmental Actors in Cambodia led by Louvain Cooperation, jointly developed and submitted a proposal to the Learning Fund Initiative call for proposal which is a joint-initiative by three federations, ACODEV – Fiabel – ngo-federatie, aiming to promote collective learning within the JSF (Joint Strategic Framework) members.

This proposal has been designed jointly by all members, highlighting the need of all members to improve their capacity to better evaluate the effectiveness of programs aiming to change behaviors. The overall objective is to draw from different evaluation methods to highlight the most effective way to measure impact of behavior change activities. To this end, a mapping and compilation of the existing evaluation methods or tools used by four JSF members (World Wildlife Fund for Nature (WWF), Louvain Cooperation, VVOB Cambodia, and Eclosio) to assess the effectiveness of their behavior change programs have been conducted.

An external consultant (Kantar-TNS) has been recruited to conduct this study on a toolbox for measuring the effectiveness of programs working on behavioral change.

This study aims to meet the following key objectives:

➤ Review, identify and evaluate best management practices aiming to evaluate the effectiveness of behavioral change center programs in Cambodia

 \succ Develop a toolbox evaluating effectiveness of behavioral change-center programs in Cambodia

> Share among JSF members the mapping and the evaluation of behavioral change methods

➤ Provide recommendations, specifically on the gaps of the 4 JSF members' selected programs on behavioral change and M&E tools

II. Activities

The first contract between the Fiabel representative and LC General Director was signed on 10th November 2018 and the amendment of the contract was signed on 11th March 2019 to extend the project period. The project period is from 1st October 2018 to 31st Dec 2019.

After the funding was confirmed, LC informed JSF partners and started to develop the Term of Reference for consultancy job to advertise on Bong Thom.com website. Three consultancy firms submitted their proposal to LC. The first one is the private Freelance consultant namely Sreang Sopheak, the second one is GLEAN private firm, and the third one is Kantar-TNS private firm. Their proposal and CVs were sent to JSF members to conduct the evaluation and selection of the relevant consultant based on agreed criteria. LC, Eclosio and VVOB staff provided their feedback and they all chose Kantar-TNS private firm as the best consultant mainly due to their sound experience in relevant topic on behavior changes, relevant experience in conducting social research in Cambodia and more in-depth research on our current tools.

After the approval from JSF members, LC took the lead to prepare the contract between LC and Kantar which was signed on 10th May 2019, following by inception meeting on methodology and implementation plan with JSF members on 4th June 2019. 7 participants attended this inception meeting (two from Kantar-TNS, one from Eclosio, two from LC, one from VVOB and one from WWF). The objective of the meeting was to present the framework and methodology of the study related to behavioral change evaluation toolbox. Four organizations (LC, VVOB, WWF and Eclosio) receiving funds from DGD were selected and agreed to engage more in this study. These four organizations were asked to send the relevant documents for the desk review before conducting the field interviews.
